

# **CORNELL UNIVERSITY** ADVANCED CERTIFICATION IN REAL ESTATE AND HOTEL INVESTMENT

Designed for managers in hotel real estate and investment, and for seasoned managers who anticipate a move to those roles or who desire a fuller understanding of the principles that guide owners and investors. This certification is comprised of six interactive online courses and two intensive three-day classroom courses. Successful completion of the online courses is required prior to arriving on campus.

This certification will help owners, operators, and lenders use their interests in hotel real estate strategically to grow their businesses and to prosper throughout the market and asset cycles. The required courses use applications from the frontier of real-estate investment to examine international capital markets, deal structuring, advanced debt and equity financing,

### **Required Online Courses:**

Well-structured hotel real estate investments create value and provide benefits to all partners in a deal - owners, management companies, and/or franchisees. Understanding the value of hotel real estate investments and the dynamics of the financial and operational aspects of real estate investments, asset management, and management contracts is critical to the success of mid-level and senior management in the hospitality and real estate industries.

This online series focuses on developing a comprehensive knowledge base and tool set that enables participants to fully understand the complex dynamics surrounding the hotel real estate and management contracts from the point of view of the property owner, operator, and lender. This multi-party view fully enables participants to structure and negotiate the most advantageous agreement taking into account the motivations of all interested parties.
